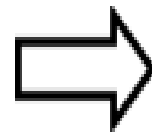

## Frequently Asked Questions:

### What do you play at All Sports Camp?

- ★ A bunch of super fun games: soccer, handball, ultimate frisbee, spikeball, steal the bacon, racket baseball, kickball, floor hockey, pinball/castle ball, and more! It's like a fun gym class ALL DAY LONG!!!

### Do kids ONLY play soccer at soccer camp? (or ONLY play baseball at baseball camp?)

- ★ No! In addition to sport-specific skills (e.g. dribbling, passing, & shooting for soccer camp), athletes play games and teach tactical elements of the games. (e.g. handball is played at soccer camp to teach kids about spacing on the field, besides just being a fun game!)

### What happens if it rains?


- ★ In the event of heavy rain or thunder/lightning, camp is moved indoors in the high school gymnasium.

### How does the multi-week and multi-child discount work?

- ★ The first week (or child) is full price (\$300). Any additional weeks (or children) is \$25 off (\$275)
  - Example 1: A camper attends both soccer weeks (300+275 = \$575)
  - Example 2: Two siblings attend both soccer weeks (300+275+275+275 = \$1,125)

RELEASE AND WAIVER OF LIABILITY (PLEASE READ CAREFULLY BEFORE SIGNING) The undersigned hereby acknowledges that participation in the camp and related activities involves an inherent risk of physical injury, and the undersigned, on behalf of the registrant, hereby assumes all such risk and does hereby release and forever discharge the camp and all employees and agents thereof from any and all known liability of whatever kind of nature, arising from and by reason of any and all known and unknown, foreseen and unforeseen body and personal injuries, damage to property, and the consequences thereof, resulting from the registrant's participation in or involvement with this camp, including any failure of equipment or defect in the premises. Any photographs taken at the camp are subject to be used in the brochure or website in future years and can possibly be used for advertising the camp. I hereby state that I am the legal guardian of said child.

### **ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY RELATING TO CORONAVIRUS/ COVID-19**

I understand and acknowledge that the novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Arsenal Elite Athletics has put in place preventative measures to reduce the spread of COVID-19; however, Arsenal Elite Athletics cannot guarantee that the undersigned, their child/children, or others who visit its location or who participate in any event or program sponsored by Arsenal Elite Athletics, will not become infected with COVID-19.

I agree that I will not attend or participate in any event or program conducted at or sponsored by Arsenal Elite Athletics, nor permit my child/children to do so, for at least 14 days after (i) returning from highly impacted areas subject to a Center for Disease Control and Prevention (CDC) Level 3 Travel Health Notice, (ii) exposure to any person returning or traveling from areas subject to a CDC Level 3 Travel Health Notice, or (iii) exposure to any person who has a suspected or confirmed case of COVID-19.
